Update on Title III grants

Northeastern State University is pleased to announce the receipt of two significant Title III grant awards: Part A, Strengthening Institutions Program (SIP) and Part F, Native American Serving Nontribal Institutions (NASNTI). The SIP provides \$1,607,616 over the next five years to establish a Student Academic Success Center on the Tahlequah campus, which will provide academic program consultation, referrals, and career advisement for all students at Northeastern, especially those identified as high risk and/or minority student populations. The NASNTI grant award in the amount of \$1,843,959, also over a five year period, will create an Indigenous Scholar Development Center to provide American Indian students with extensive academic services and programming, as well as provide for faculty and staff development and community outreach projects. The Student Academic Success Center and the Indigenous Scholar Development Center will work in tandem to significantly increase the retention and graduation rates of high risk, low-income, American Indian and other minority students at Northeastern State University.



Expanded cabinet notes 9.27.11

CABINET MEETING NOTES Tuesday, September 27, 2011

Enrollment Report: Shelly Dreadfulwater and Jason Jessie reported a small decrease in enrollment for fall 2011. Exact reasons have not yet been determined but there was a decrease in first time freshman numbers. Recruiters are already working on fall 2012 efforts. NSU will host a college fair that will include eight area high schools. They discussed the GoNSU Portal. Financial Aid portals have been tested to ensure they are working properly for the Student Go Live date. Financial aid staff is still working out of two systems. Approximately 25 million in federal aid has been disbursed (this amount does not include tribal or tuition waivers). New SAP policy requires changes due to new Dept. of Ed Program Integrity Rules. These changes make the reinstatement of aid requirements stricter. Institutions must implement an academic success plan for those students who are allowed to continue receiving federal aid yet are not meeting the minimum requirements of the academic progress policy. This plan must be monitored after every semester of attendance for which the student is allowed to continue to receive federal aid. The program integrity rules reiterate that financial aid's main purpose is to help students obtain a college degree while ensuring that funds are being utilized for that purpose. The Strategic Enrollment Plan process is in its final stages. Expansions within Career Services will include an online resume service. Implementation of services into mainstream student life is a priority of the department.

New Hire Background Checks: Dr. Martha Albin discussed the new policy in the final stages to require the completion of background checks on potential new employees. These checks will focus on criminal and sex offender backgrounds only. The checks will not be the only determination of hiring. HR will work with Public Safety and departments on any issues that arise. Costs will be covered through HR. Turnaround time should be quick and no slowdowns in the hiring process are expected.

Employee Drug and Alcohol Testing: Dr. Martha Albin discussed efforts toward implementing a drug and alcohol testing program. This testing will not be random or periodic but based on certain criteria determined within the policy. This program is consistent with peer institutions with NSU being the first RUSO institution to implement it. Testing will only be utilized for "cause" with HR determining the need. It was reported that NSU's EAP program is doing an excellent job working with employees in this area.

EthicsPoint: Dr. Martha Albin RUSO EthicsPoint Service Tip Line. This system will provide a way for anyone to discreetly and confidentially report activities which may be unethical or otherwise inappropriate behavior in violation of established policies. The Tip Line will be made available on all RUSO institution websites. A letter will go out to employees when the system is made available. This system is a three phase process. The first phase is the report that is submitted to the RUSO office for review based on predetermined criteria. RUSO will then disburse a report to the institution. The third phase will include an investigation by the institution with a report submitted to RUSO of any findings. All information will be stored off site for system integrity purposes.

Expanded Cabinet: Discussions continue on the beneficial outcomes of this group. A value approach may lead to better group dialog that will produce

effective and purposeful outcomes. Notes from previous Cabinet meetings will be distributed to the group in an effort to help define expectations of this specific group. It was determined that more discussion will be needed at the next meeting.

CABINET MEETING NOTES Tuesday, September 20, 2011

Meeting conducted while in transit to Oklahoma City for Regents Education Program.

University of Arkansas: Dr. Bahr met with the Dr. Todd Shields, Graduate Dean and Dr. Stephan Sheppard, Professor of Law from of the University of Arkansas regarding partnerships in academic areas and other opportunities. It was decided not to partner with U of A in developing a Naval ROTC program due to space limitations, finances, and competition with our Army ROTC program.

Capital Project Update: A brief update was provided with more information to follow on the printed facilities management updates to accompany the minutes.

Career Services Initiative: Continued discussion of the Career Services build out. We are continuing to evaluate appropriate space needs. Need a more detailed plan including specific goals and objectives with quantifiable measures for assessment based on best practices.

Nigh Academy Nomination: Decided to have Dean Boren develop an application process to select a student to attend the Nigh Academy. Nominations are due November 15.

Ethics Point: This was discussed at the RUSO board meeting. Rollout is set for October 17. Initially all complaints filed by RUSO institutions will go to Regent Jan Gordan for review.

Title III Grants: A small Steering Committee will be formed to coordinate planning for implementation of the two Title III grants. Laura Boren will organize the small group. The release of publicity regarding these two grants was discussed. The steering committee will draft an initial PR release and all cabinet members will be asked to critically review the draft.

New ID Cards: The design for new ID cards was discussed. It was decided to let NSGA and student senate provide feedback on what design they liked best.

Non-Academic Program Reviews: David Koehn provided a draft to cabinet members of a review process for non-academic programs. Cabinet members were asked to review the draft and be ready to discuss at the next full cabinet meeting and to be thinking about the committee structure for review of plans.

IT Positions: David Koehn provided a handout of IT positions. There are currently 10 unfilled positions. 4 of these positions will be placed on hold and not filled immediately. 3 other positions have been reorganized to better meet our needs as we go forward with Banner and other IT projects. Eliminating these 3 positions will provide for an annual savings of \$103,000 including benefits.

ITV Rooms: David Koehn initiated a discussion regarding the continued use and upgrade of ITV rooms. We will ask the CTL Steering Committee to take the lead in recommending a strategy for transitioning away from ITV instruction and moving to desktop based technology.

Unlearning....education as training or education as something else?

Henry was my adviser in my doctoral program at Miami University, and presented me with perspectives concerning the purposes of education that resulted in a dramatic change that went to the core of my belief system. Isn't that what a doctoral program should do...present you with perspectives that you have never considered previously? Isn't that what higher education should be about regardless of degree?

Or should we be about 'training' for the job market?

Being 'trained' to teach through my bachelor's program and 'trained' to be a school administrator through my master's degree program, I had to unlearn those patterns of thought and accompanying practice while in the doctoral program with Henry, Peter McClaren, and their colleagues. If I didn't unlearn, I was going to leave education.

You see, I enrolled at Miami U to pursue professional writing, NOT to continue

my path in education. I was disenchanted with teaching. However, I had to take ONE curriculum course and transfer it to Utah State University in order to complete my master's degree there. That one course was with Henry during the summer of my arrival at Miami U. During that course, an awakening occurred. I began to unlearn all of the technocratic, drill and skill, teach for the test, prepare for the world of work, etc. philosophical and practical beliefs ingrained in me throughout my own schooling. As a result, by the end of that course, I recommitted to staying in education as a professional path, applied for admission in the Educational Leadership Ph.D. program, and withdrew from the professional writing program.

After the two year residency in the Ph.D. program, I returned to teaching middle school for two years while completing my research and dissertation, and my approach to teaching and learning was a 180 degree change from the previous years. I was no longer disenchanted. Even middle school students need to unlearn as well as learn; just as I needed to do.

Why am I sharing this?

Because I still believe that Henry Giroux is more right than wrong. I still believe that we need to unlearn as well as learn during our lifelong pursuit of knowledge and understanding. I also believe that higher education is under attack, that the attack is purposeful, and that the ultimate goal is the privitization of education... commodification of courses, programs, and degrees...such that schooling, not education, is what we are all about. If schooling, then our work is to prepare people for jobs, jobs, jobs; get our students to pass the tests, tests, tests; and implement a curriculum that aligns with those tests.

What about democracy? Democratic processes? Democratic principles? Equity, justice, critique? Dialogical conversations? Inquiry? Freedom of expression? Freedom to speak without fear of losing your job or of receiving a bad grade?

Campus Update 9.25.11

Dear campus community,

This is an exciting time for Northeastern State University! While we are busily engaged in Banner implementation, preparations for our NCATE and HLC accreditation visits, and a host of other projects, we continue to receive good news. I would like to share some of that good news with you.

Notification of two major grant awards

We received notification that at least one of the two U.S. Department of Education Title III grants applied for last year has been funded. We are anxiously waiting to hear on the second proposal. The already funded award will support our efforts to provide new approaches to mentoring and advising students, professional development for faculty and staff, consolidation of student support services already in place, and planning/design and initial staffing for a Student Success Center. As soon as we hear formally on the second proposal we will immediately form a small steering committee comprised of those involved in writing both proposals to design an implementation strategy, bring a broad base of faculty/staff/students/community members into the implementation process, define steps needed to accomplish the grants' objectives, and develop a timeline delineating tasks that must be accomplished and responsible parties for completion of those tasks.

Congratulations go out to those whose work was responsible in securing the initial \$1.8 million dollar award, including members of Research & Sponsored Programs, Student Affairs and Enrollment Management.

Approval of facilities projects

Our RUSO Board of Regents has approved several campus projects that will begin over the next few months:

- 1. Construction of an Events Center/Arena
- 2. Re-roofing of the Administration Building
- Remodel of the Muskogee campus student services area to integrate Connors/NSU financial aid and enrollment services
- Preliminary planning for two phases of construction for new student residential facilities on the Tahlequah campus, replacing antiquated residence halls
- 5. Fitness Center upgrades to the pool
- 6. Remodel of old OSBI facility for new National Science Foundation funded research labs
- 7. Remodel of space at the BA campus for creation of a new Low Vision Clinic for the community of Broken Arrow

Work continues on:

- 1. Cappi Wadley reading and technology center in the College of Education
- 2. Renovation of stadium press box
- 3. Construction of new entryway for soccer field
- 4. Completion of the Redmen Heritage Wall and Second Century Plaza for dedication this semester
- 5. Campus lighting enhancements
- 6. Parking lot upgrades for Garrison and Seminary Street parking lots on the Tahlequah campus
- 7. Center for Performing Arts green and circle drive construction
- 8. Completion of Cue/Bowl in the UC Basement and the BA Fitness Trail

Miscellaneous

- Friends of NSU have offered significant financial support for the Events Center that allows us to add approximately 20,000 sq.ft. of additional space to the original design to use for conferences, workshops, trade shows, career fairs, etc. We have friends of NSU who have offered financial support for a variety of other projects listed above in the facilities area as well. Many of our facilities projects would not be possible without that support. More information about that support will come throughout the year as appropriate.
- NSU will be a sponsor for the City of Tahlequah's winter festival this year. One component of that festival will be an ice skating arena at Norris Park from Thanksgiving through Christmas, open to the public. You will hear more about this as we approach the holidays. As a sponsor, NSU will host two 90 minute time periods for faculty/staff and students to skate for free.
- Due to implementation of a student fee for career services, we will be greatly expanding our Career Services office, providing additional support services for students on all three campuses in their pursuit of career readiness, internships, and career placement. We expect that students will be immediately connected to Career Services upon arrival at NSU and will sustain a close working relationship with center staff throughout their time with us.
- We are entering into an agreement with the Cherokee Nation and KATS to
 offer shuttle services from NSU Tahlequah to Reasor's/Wal Mart and along
 Downing Street on a set schedule several times each day for our students,
 faculty/staff. There will likely be a small charge to take the shuttle, but
 regular routes/times are being planned, and the shuttles should be running on
 those schedules within the next few weeks.
- We have permission from the City of Tahlequah to install two table-top speed bumps along Grand Avenue which runs through the middle of the Tahlequah campus. Those should be installed this semester, which we hope will greatly enhance pedestrian safety.
- We recently visited a FAB Lab (fabrication lab for developing prototypes) that is connected to middle/high school curriculums in math/science and is also used by community inventors/entrepreneurs, business and industry, and college/university students. We believe that there is high probability that we will secure funding for a FAB Lab in Muskogee and in Tahlequah soon. There are still conversations that need to occur, but we have high interest among some friends of NSU to pursue development.
- Our Strategic Enrollment Management Plan is nearing final draft. We plan to have that draft out to the campus governance groups soon for review.

CABINET MEETING NOTES Tuesday, September 13, 2011

Capital Projects Update: Current projects are progressing as planned (see attached). Three important dedications are being planned in the near future. Second Century Square dedication is being planned for October 10 as part of homecoming events, the Deloache Soccer Sign dedication will be on October 23, and the Redman Heritage Wall dedication will be on the day of our last home football game which is November 12.

IKON Print Manager Software: Sometime in October 2011 IKON personnel will begin training that will allow for more effective utilization of our copiers as printing devices as a cost cutting measure. More information will be made available as this process is developed.

New Student/Employee ID Cards: A system is being implemented to replace the current ID cards for faculty, staff, and students. This updated system will be more secure by changing to the unique Banner ID number and removing all use of SSN references as an identifier.

In-House Consultant Usage: Discussions are ongoing regarding the use of in-house professionals for consulting purposes. With this, faculty and/or staff with expertise in needed areas will be given the opportunity to offer competitively priced consulting services. More information will be provided as these discussions are finalized.

Unduplicated Headcounts: Dr. Bahr explained how unduplicated headcounts have been produced in past. A specific matrix has been utilized for several years in the way each student is counted at each location enrolled. As our systems are updated, there is a potential to produce these numbers by different methods. After discussions of the need for changes, it was decided that no change will be made in this calculation method at this time.

Indigenous Center Update: Dr. Ron Cambiano briefed members on the history of plans for an Indigenous Center. Based on the work of Wilma Mankiller, while a Sequoyah Fellow at NSU, and a dedicated group of people, plans continue to develop this center.

Career Services Initiatives: Funds are now available to expand services for students at both the Broken Arrow and Muskogee campuses. Locations are being surveyed as

anticipated needs for space are evaluated. Discussions will be ongoing as plans develop.

Expanded Cabinet: Discussions continue on the outcome needs of this group. A more focused approach may lead to better group dialog that will produce effective and purposeful outcomes. Discussions will continue with this expanded group at our next meeting.

Business and Finance Updates

Major Initiatives

- Banner implementation Finance system went live on July 1, and work continues to completely migrate accounting system into Banner. Teams continue to work extremely hard as we move towards scheduled go live dates for the Student, Payroll/HR and Development systems.
- Budget Oversight Committee is working on development of a budget plan for FY 2012-13.
- Compensation Review Committee is continuing to work on a comprehensive review of our employee classification and compensation system.
- Non academic program review planning and development of evaluation criteria is ongoing.

Business Affairs

- Accounting department is focused on the annual financial audit currently underway by the accounting firm of Cole and Reed.
- Accounting department is continuing to test and adjust temporary interfaces between the new Banner Finance system and legacy systems. These systems are primarily the student accounts receivable system currently in Osage, and payroll which is currently in Oracle.
- The student ID staff are preparing for the process of re-carding the entire campus due to the transition to a Banner ID number from using the SSN for identification.
- The student accounts receivable (AR) staff are preparing for the conversion to Banner. This change will impact how students access their account information and how payments are processed.
- Payroll staff are also preparing for the Banner conversion, working toward changes in the time and attendance system.

Budget

- Budget staff is working on year end reporting to the State Regents, RUSO and other external entities.
- Also beginning work on the annual budget needs survey for fiscal year 2012-13 due within the next month to the OSRHE. This report submits prioritized request for new budget, mandatory cost increases and cost saving reporting for inclusion in the OSRHE annual budget request to the Legislature.

Information Technology

• Focusing on support for Banner implementation, Blackboard upgrade, degree audit upgrade, and housing management system implementation.

- Continuing campus discussions and dialog to put together a comprehensive IT governance plan for the University.
- Putting together an annual PC replacement plan for the university which will allow us to keep our equipment under warranty and current to allow upgrades to new software as available.

Purchasing

- Continuing to focus on building proficiency with the new Banner purchasing module, and assisting departments with training and assistance.
- Working on numerous significant project bids, such as the Housing master plan and the Multipurpose Events Center.

Grants and Contracts Administration

- Compiling requested information for Cole and Reed for the A-133 (Federal compliance) audit.
- Continuing new grant account set-up in Banner, and working through implementation with grant support staff.
- Close-out of grants for the fiscal year end (6).

• Office visits were conducted in Washington, D.C., with Senator Inhofe, Congressman Boren and Congressman Sullivan in conjunction with the Oklahoma Fly-in. UR advanced the need for federal support in our programs including: STEM lab build-outs at NSU-BA; American Indian School of Health Professions at NSU-Muskogee; EB-5 reauthorization; Economic Development Administration demonstration grant; and Department of Defense certification of NSU's online programs for delivery to military units world wide.

- Washington, D.C., conversations with Congressional delegation members and Oklahoma executive officers resurrected the potential for federal funding to support NSU's request for funding CNG buses as a shuttle service between Tahlequah and Broken Arrow. In 2009 the Oklahoma Department of Commerce approved \$800,000 for the purchases of four CNG buses, but the U.S. Department of Energy chose only to fund retro-fits with ARRA stimulus money. This latest initiative could capture some of those unspent funds for new buses if funding is still available.
- Using public databases we have identified about 3,000 NSU alumni who aggregately has sufficient resources to donate \$110 million to non-profits. By national formulas, at least \$20 million of that should go to higher education. We are completing our plan in the Foundation on how best to deploy our existing staff resources, and delineating those needed, to cultivate those donors.
- An alumni gathering in Washington, D.C., and a meeting with alumni in Oklahoma City have resulted in requests to form Alumni Chapters in both cities. We are exploring those opportunities, including identifying possible leaders as well as the clubs' respective purposes of networking, etc.
- Design and editing templates are underway in Communications for the Higher Learning Commission Self-Study, which is currently under review by an outside reviewer. Communications will receive the document on Oct. 1 for layout on the web, in a CD, and as a printed document. Preparation is underway to lay the groundwork for an expeditious project, which must be completed by Dec. 21 for final review before submission to the Site Review Team.
- Communications is reviewing its work flow and project coordination to share timelines and deadlines information with the campus community on new projects. Currently the department is managing 90-some writing, editing and design projects. With the Oct. 1 acceptance of the HLC study its web top priorities will be: No. 1, HLC site build out; No. 1, Departmental web pages build-out; No. 1, Lumina project build-out.
- University Relations has been asked to take the lead coordinating the development of a RUSO system campuses legislative strategy for 2012. This will include: scanning the environment and responding to unfounded criticisms of higher education; describing the specific strengths of the RUSO campuses as the primary educator of Oklahoma's workforce and improving its quality of life; and advocating for our appropriate share of state resources. Groundwork has already been laid and the RUSO board is expected to give its approval for this project to move forward and continue throughout the legislative session.
- The Marketing Communications committee will meet next week to review all collaterals publications currently published by NSU to support student recruitment. This inventory will check for branding and messaging consistency; identify gaps in our communications to prospective students; review this academic year's publication schedule for re-prints and print-on-demand; determine needed collaterals to establish a timely and manageable work flow through communications; and recommend budgetary funding for next fiscal year to more fully support our underfunded student recruitment publications needs.
- Numerous miscellaneous major institutional visibility projects are underway to garner additional media visibility for NSU through

recognition of our alumni and friends.

- Higher Learning Commission "Did U Know" planning continues with the Duct Tape Contest; Found Art Contest; DUK Dogs colleges promotional events; "I Want my HLC" video; and DUK quiz on the NSU phone application.
- Miscellaneous communications projects are underway, including "Reflections," which will be distributed to RUSO Regents and the broader community; "Imprints," the alumni magazine; and direct mail fundraising solicitations to support scholarships both to COE alumni and key alumni identified through the database review.
- An MOU is nearing completion on Foundation support to a Cherokee Nation scholarship program directed toward developing Cherokee students as future leaders through an on-campus Living/Learning community.
- Working with the Regional Plan, UR through its leadership on the Common Vision, Common Voice committee, advocated successfully for adoption in the 14-county's regional 2012 Legislative agenda its support for \$1.5 million in state funding to launch academic majors associated with the American Indian School of Health Professions program at NSU-Muskogee. Next week Dr. Dilene Crockett will facilitate the regional discussion on the constitution and bylaws of a proposed 501(c)(3) to serve as the coordinating organization for the regional plan.

Future funding models, etc.

At the OSRHE president's retreat yesterday, were told that the current legislative climate in OK indicates that higher education will be fortunate to receive a 'status quo' budget allocation next year. This means that despite the state having a budget that allows some catch up in allocation, we should not plan on an increase.

There is a lot of speculation and opinions as to why that is the case, and much of it comes down to statements that many legislators do not believe that higher education is efficient or accountable...that we don't produce enough quality graduates for the funds we receive, etc. Also, there are published reports showing that universities and colleges in OK are SPENDING more each year, not reducing their spending, and many are buying those reports on face value rather then giving them full consideration.

For example, I will go back to what I said in a previous post: NSU spends 18% less per student now than 5 years ago. We have absorbed state reductions and tried to limit tuition and fee increases as much as possible to protect students. Its pretty simple mathematics that will show anyione that data.

So why and how have we increased spending?

Our student enrollment has increased and our fixed costs have increased at a faster rate than has our 'income.' We have done a good job generating external funds through grants, contracts and giving to help offset those costs, but the simple explanation is that with more students and increased fixed costs, you spend more to cover those regardless of where the funds come from. With state allocation decreases, we must scramble to find other ways to cover the costs incurred with additional students and rising fixed costs. So yes, we are spending more, but not due to an increase in state allocation.

To go back to my summers working at Dairy Queen...we added staff in the summer to cover the costs of the rise in customer numbers as the road to the North Carolina beaches filled up. We bought more product in order to meet demand as well. I'm sure the utility bills went up during the summer as well. Bottom line...we spent more in order to cover our costs which rose during the summer.

However, if we spend more as a university in order to accommodate more students and meet increasing fixed costs, we are criticized for being inefficient.
